## **#1. White Butte Detachment Staffing Update:**

-S/Sgt. Detachment Commander, Sgt. Operations NCO and Cpl. Supervisor NCO positions are all filled at this time.

-All Cst. positions are all filled at this time.

-Cst. Jordan Norstrom has been recently identified to be promoted to Depot Division and will be working in the Firearms Training Unit. Staffing is working on finding a replacement for Cst. Jordan Norstrom.

#### #3. Calls of Interest:

1 – \*\*\*Important file updates this period\*\*\* On September 21<sup>st</sup>, members were called to the Sobey's Liquor store in Emerald Park due to a theft involving a large amount of alcohol from the store. Members have been conducting a thorough and diligent investigation into the incident. Turns out there were three males involved. Since the initial incident all three have been charged and two have been arrested and sent to court so far. 44 year old Devon Brehaut has been charged with theft under \$5000.00. 30 year old Dexter Neufeld has been charged with

theft under \$5000.00. 34 year old Ryan Neufeld has been charged with theft under \$5000.00. One of the males is currently on warrant status. File 2023-1407674 refers.

2 – \*\*\*Important file updates this period\*\*\* On September 23<sup>rd</sup>, members were called to the Home Hardware in Emerald Park due to a theft of a snowblower. Members have been working hard to identify suspects and bring the case to the point of charges. November 24<sup>th</sup> members were able to charge two males with theft under \$5000.00. Dexter Neufeld and Ryan Neufeld have been charged in relation to this incident. One male has been dealt with by the courts and the other still has a warrant out for their arrest. File 2023-1419110 refers.

3 - On November 25<sup>th</sup>, members conducted a vehicle stop on a suspicious vehicle on Highway #1 near White City. There were inconsistent things that arose from the traffic stop and subsequent investigation. The male driver was from Ontario. An arrest and search of the vehicle yielded a large amount of drugs that were seized. 36 year old Lloyd Allen was arrested and charged with Possession Over 30g dried Cannabis under the Cannabis Act and Dive while disqualified under the Criminal Code. File 2023-1741222 refers.

4 – On November 28<sup>th</sup>, White Butte Detachment was called to the Town of Belle Plain to a complaint of counterfeit bills / money being uttered. Turns out there was over \$1000.00 of counterfeit money uttered. The investigation ended up with charges against 45 year old Ryan Buckton being arrested and charged with Possess Counterfeit Money and Utter Counterfeit Money under the Criminal Code. He was also charged with Failing to Comply with release order conditions. File 2023-1757117 refers.

5 - On December 22<sup>nd</sup>, White Butte members were responding to a 911 traffic hazard call near the Town of Kronau. One of the members was able to find and intercept the offending vehicle to conduct a traffic stop. The investigation showed gross signs of impairment from the driver and a breath test was completed resulting in readings over double the legal limit. 32 year old Gloria Lerat was charged with Impaired Driving and Drive While Over 80mg% under the Criminal Code. File 2023-1873867 refers.

6- On December 25<sup>th</sup>, White Butte Detachment were called to a sudden death in the Town of Balgonie. EMS and the Balgonie Fire Department responded to the scene as well. Sudden death files are investigated in such a way as to rule out any foul play. This file there was no foul play suspected. Next of kin was completed with the family along with a proactive victim services referral. Coroners final report outstanding. File 2023-1884620 refers.

7- On January 2<sup>nd</sup>, White Butte members were called to a single motor vehicle collision that took place on the Regina Bypass. The vehicle was not only involved in the collision but seemed to now also be on fire. Regina Fire Department and EMS on scene. Sadly the motor vehicle collision investigation revealed there to be a single fatality. No foul play suspected. Next of kin and Victim Services completed. File 2024-9508 refers.

**#4. RPCC Investigations.** 1 unlawfully at large, 2 assault peace officer, 3 assaults, 1 MHA, 1 theft under \$5000.00, 1 CDSA, 1 missing person and 47 assistance files. The total for the reporting period is 57.
