#1. White Butte Detachment Staffing Update:


- -S/Sgt. Detachment Commander and Sgt. Operations NCO positions are filled at this time.
- -Cpl. Tyson Greig has been promoted to the L.A.S.T. at "F" Division HQ which has created one Cpl. vacancy at this time. We are currently advertising the position for promotion to try and find a replacement.
- -Cpl. Travis Davidson has been transferred to Depot Division which will create a second Cpl. vacancy. We are currently working with our staffing department to try and find a lateral replacement.
- Cst. Nicole Peddigrew has been transferred here from Yorkton Detachment, but has yet to arrive due to a house sale at origin.
- One Constable vacancy at this time.

#3. Calls of Interest:

1 – On March 18th, White Butte members received a request for assistance from Indian Head Detachment of suspicious persons and possibly a stolen vehicle in the Town of McLean. White Butte members arrived to assist and the vehicle seemed to be stuck out in a field near the RM shop on the North side of the rail road tracks. The investigation eventually lead to members actively pursuing the vehicle for a short distance until the danger became too great and the pursuit had to be abandoned. Regina Police Service aircraft was able to maintain a visual on the suspect vehicle which was driven into Regina and abandoned in a residential area. 32 year

old Dylan Beler of Regina was charged with resist/obstruct peace officer, Section 129 of the Criminal Code. Flight from police officer, Section 320 of the Criminal Code. Mischief over and under \$5000.00, Section 430 of the Criminal Code. Dangerous operation of a motor vehicle, Section 320 Criminal Code. Fail to comply with probation order, Section 733 Criminal Code. A 17 year old female was charged with obstruction Section 129, flight Section 320, mischief over Section 430, mischief under Section 430 and dangerous operation of a motor vehicle Section 320. File 2024-357082 refers.

- 2 On March 30th, White Butte received a complaint of a stolen vehicle and the registered owner was following the stolen vehicle in the rural areas near McLean. Members attended to the area and located the stolen vehicle driving in the Edgeley area. Members tried to stop / wanted to attempt to use a spike belt to disable the vehicle. Spike belt was attempted although not successful. 2-3 kms down the road as members pursued the spike belt was attempted once again. This time the belt was successful. The stolen auto was disabled. 35 year old Jessica Pangman of Regina was arrested and charged with obstruction, Section 129 Criminal Code. Flight, Section 320 Criminal Code. Take motor vehicle with out the consent of the owner, Section 335 Criminal Code. Dangerous operation of a motor vehicle, Section 320 Criminal Code. File 2024-412960 refers.
- 3 On April 6th, White Butte received a call to the Town of Pilot Butte. The call was that an ex boyfriend had showed up at the residence and there was now an assault or assault with a weapon in progress. Members attended the residence and completed the investigation. Investigation revealed that a domestic assault had taken place and the accused had fled the scene. Members remained on scene to wait for the accused and later the accused did come back to the residence where he was promptly arrested. 41 year old Eric Wolkowski of Pilot Butte was charged with choking, Section 267 Criminal Code. Assault with a weapon, Section 267 Criminal Code. 5 X fail to comply with a probation order, Section 733 Criminal Code. Operation While Impaired, Section 320 Criminal Code. Operation while over 80 mg%, Section 320 Criminal Code. File 2024-446842 refers.
- 4 On April 11th, on duty White Butte member was at the Detachment when they saw a vehicle pull up to the Detachment and a person got out of the vehicle, only to act in a peculiar type of way. The member went to speak to the male and learned that they were at the Detachment currently to lodge a complaint of a person that was driving while distracted on their cell phone. The member could immediately detect that there was alcohol coming from the male. The investigation pivoted into an impaired investigation where the 30 year old male, from Regina, ended up failing the roadside screening device and was ultimately charged with operation while impaired of a motor vehicle and operation while over 80 mg%. Braden Markel will be making his first court appearance in Regina for the matter. File 2024-474675 refers.
- 5 On April 12th, White Butte received a complaint originating from Greenall School in Balgonie of a fight between some students as there was no lunchtime supervision. The victim from this date was involved in a file a few weeks ago in an altercation with a female at the

school as well. Members investigated the file this date and will be charging two youth with assault. File 2024-478529 refers
