#1. White Butte Detachment Staffing Update:

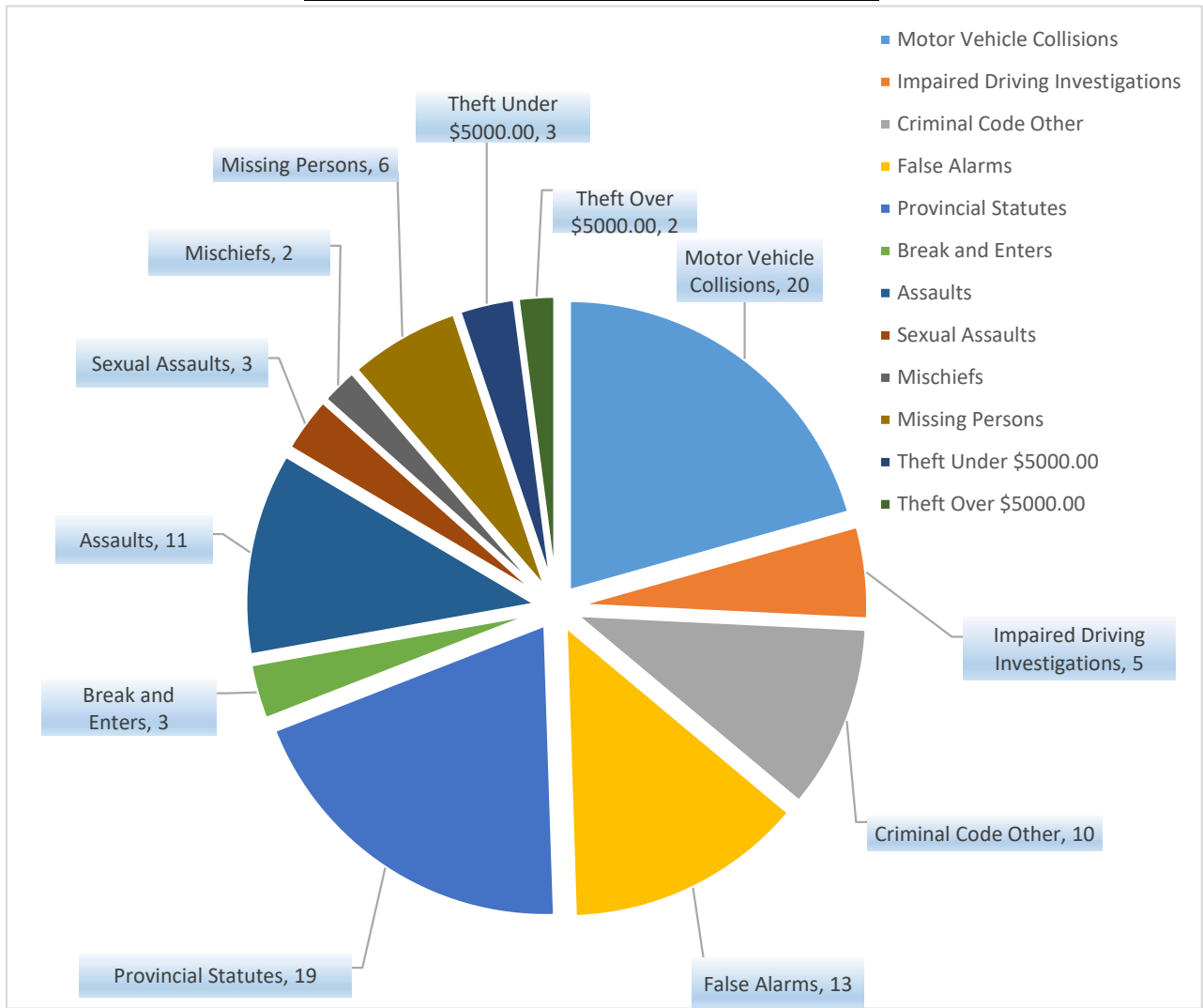
- S/Sgt. Detachment Commander, Sgt. Operations NCO and Cpl. Supervisor NCO positions are all filled at this time.

- Staffing has identified a possible candidate to join the team here in White Butte.
- One Constable vacancy at this time.

#2. Calls for Service – Analysis last 28 days (January 18, 2024 to February 15, 2024)

- Total of 983 occurrences generated.
- 20 traffic collisions - (11 reportable, 7 non-reportable, 2 injury).
- 608 traffic offences - (253 for speeding, 29 other moving violations, 5 drive while suspended, 255 other-non-moving traffic, 66 other activities).
- 5 impaired driving.
- 19 provincial statute investigations - (4 mental health act, 10 911 act, 2 fire prevention act, 1 liquor act, 1 trespass act, 1 coroners act).
- 1 municipal bylaws other.

#3. Calls of Interest:

1 – On January 4th , White Butte Detachment received a call from the principal of Greenall High School about a person threatening to possibly shoot up the school in the near future. The principal advised that the threats were online threats. The person making the threats was a former student of the school and is 17 years old. Members completed their investigation into the threats, arrested and charged the former student with uttering threats and mischief under \$5000.00 as per the Criminal Code. File 2024-17890 refers.

2 – On January 16th , White Butte received a call on 48 Highway that a male was sitting in his pickup truck passed out behind the wheel. The incident was suspected to be alcohol/drug related. The truck was in the middle of the driving lane near the Town of Kronau. Members attended the scene and conducted an impaired investigation. Subsequent to the investigation members charged 18 year old Deshawn Perras of Sedley with operation while impaired and operation while over 80mg% alcohol. File 2024-65637 refers.

3 – On January 21st , White Butte members were called to the RM of Edenwold from a woman who was a victim of a domestic assault. Members attended the scene to investigate the file and separated the involved parties. Firearms have been seized as well. Members have charged 37 year old Justin Huber with assault under Section 266 of the Criminal Code. File 2024-91104 refers.

4 – On February 2nd , White Butte Members were called to the Town of Belle Plaine from a male who advised he was the victim of a domestic assault. Members attended the scene and investigated. 61 year old Lori Scott was charged with assault with a weapon under Section 267(a) of the Criminal Code. File 2024-148743 refers.

5 – On February 7th , White Butte Members were called to the Town of Kronau from a female who advised that she was the victim of a domestic assault. Members attended the scene and investigated. Members ended up charging 30 year old Tyler Cyca with assault under Section 266 of the Criminal Code. File 2024-167363 refers.

#4. RPCC Investigations. 1 unlawfully at large, 1 assault, 2 sexual assaults, 1 disturbing the peace, 1 911 hang up, 1 carrying a weapon, 1 assault with a weapon, 1 uttering threats and 22 assistance files. The total for the reporting period is 31.
