#1. White Butte Detachment Staffing Update:


- -S/Sgt. Detachment Commander position is filled at this time.
- Sgt. OPS NCO position is currently vacant as Sgt. Lee Knelsen has been transferred to Prince Albert. The new Sgt. has been named and a transfer has been issued for Sgt. Steven Ross from Estevan Detachment due to arrive as soon as he can sell his house.
- -We are pleased to announce that the promotion to find a replacement for one of the Cpls has occurred. Cst. Nolan Rinholm will now be Cpl. Nolan Rinholm.
- Cst. Andrew Zaichkowsky's replacement has been named. Cst. Kimberly Flett has been transferred and will be joining us from Yorkton RCMP.
- Cst. Logan Ubell and Cst. Sarah Gamache will be leaving White Butte Detachment as they have been promoted to Depot Division in the pursuit of instruction and working with new cadets. Staffing is working on finding White Butte, two members to be transferred in.

#3. Calls of Interest:

1 – On September 23rd, White Butte members received a call from a motorist saying that they were following a vehicle that was swerving all over the road and fluctuating its speeds. Members from the White Butte Detachment and Moose Jaw Detachment worked together to investigate and locate the vehicle in question. Investigation revealed that the driver was in possession of a stolen vehicle and additionally had a warrant out for her arrest. 23-year-old Charal NORTON has been charged with Section 354(1) C.C. possession of property obtained by crime over \$5000.00. File 2024-1406410 refers.

- 2- On September 24th, White Butte members were called to a youth home near Pilot Butte. The complainant was an employee that was just assaulted by a youth that was wanting to leave the campus and go AWOL. The employee wanted to keep the youth safe and was preventing them from leaving and going out onto the highway. The matter was investigated and the youth was charged with Section 267(b) assault causing bodily harm. File 2024-1412647 refers.
- 3- On September 27th, White Butte members were called at 8:27am to a semi vs SUV collision on Highway 1 just east of Regina. The male passenger of the SUV was pronounced deceased at the scene by EMS. The SUV (right lane) and the semi (left lane) were both heading east bound when the SUV made a sharp left-hand maneuver to access the centre median. It was at that moment that the semi in the other lane and hit the driver's side of the SUV. File 2024-1426097 refers.
- 4 On September 28th, White Butte members received a call of multi vehicle collision due to a vehicle that was going east bound in the west bound lanes near the Belle Plaine Shell gas station. This action caused a head on type of collision with another motorist. Members attended the scene and completed an investigation into the incident. The investigation turned into an impaired operation of a motor vehicle. 22-year-old Meshack KONGO has been charged with Section 320.14(2) operation while impaired over 80mg% causing bodily harm and Section 320.14(2) operation while impaired by drug causing bodily harm. File 2024-1432263 refers.
- 5 On September 29th, White Butte members were called to the Town of Pilot Butte that a male just drove away from his house, impaired, with his 12-year-old in the vehicle as the passenger. Members attended at located the vehicle and the driver and started to investigate. 44-year-old Kelly HUBICK has been charged with Section 320.14(1)(a) operation while impaired and Section 320.14(1)(b) operation while over 80 mg %. File 2024-1440257 refers.
- 6- On October 5th, White Butte was called out to a semi unit that had blown over onto its side at the Highway 10 and Highway 1 overpass heading towards Fort Qu'Appelle. The wind this date was at times up to 90 km/hr with strong gusts for the majority of the day. Balgonie Fire Department was very helpful with slowing down traffic and keeping everyone safe. File 2024-1470864 refers.
- 7- On October 8th at 5:58am, White Butte members were called out to a glass break X 4 and south motion X 5 alarm at Happy Hour Cold Beer Wine and Spirits in Pilot Butte. Members attended the scene and saw that there was a glass break as the front door had been smashed out and entry gained into the business. Two individuals are responsible for the break in. Members continue to investigate who may be responsible. File 2024-1484490 refers.
- 8- On October 10th, White Butte members received a call from a resident of the RM of Edenwold that they just had a break, enter and theft where their pickup truck and youth quad were stolen. In and around the city of Regina that night there was a rash of stolen vehicles. After the incident the vehicle and the quad were recovered and towed for examination. White

Butte and RPS have been investigating the file and there are suspects identified and the file will likely be pending charges. File 2024-1495320 refers.
