# Highlights from the past meetings

- Rink Shack Maintenance: Weather has caused the rink to longer be a viable option as such is closed. Due to the ongoing vandalism the shack will be closed till further notice.

- Town is moving towards more environmentally sustainable practices, and will be focussing on reduction of paper. We are working towards a paperless office, which means for the rate payer; emailed receipts, notices and utility billing, online request and information. Please watch for the updates on the new PAD system, and customer portal, target is by June 2024 to be available to the ratepayer

-Road assessment, much discussion is being had about how to repair the roads, cost and the implication of the town economy and growth. There will be a Town Hall meeting on March 5th, in attendance will be Council and the Engineering consultant to discuss the findings. Council is looking forward to hearing ratepayers thoughts, to help confirm the results from the 2021 and 2023 surveys.

-Bylaw 01-2024 Water Rates Bylaw has been rescinded, there will not be any increase to the 2024 Water rates! In discussion with the SWA, their reduction in rates offsets the increase in the City of Regina rate increase, allowing for no increase in water rates for 2024.
