### **#1. White Butte Detachment Staffing Update:**


- -S/Sgt. Detachment Commander position is filled at this time.
- Sgt. OPS NCO position is currently vacant. A transfer has been issued for Sgt. Steven Ross from Estevan Detachment due to arrive, once his house is sold.
- Both Corporal positions are filled at this time.
- Staffing has been sending transfer planning documents to two unknown members. White Butte has three Constable vacancies. A Constable for Rinholm's old spot. A Constable for Ubell's old spot. A Constable for Gamache's old spot.
- The White Butte GIS spot has been vacant since the departure of Cst. Jennifer Collins this past summer and will be filled by Cst. Ken Spasoff effective January 21<sup>st</sup>, 2025.

## #3. Calls of Interest:

1 – On November 19<sup>th</sup>, White Butte members received a call from Evraz in the industrial area north of Regina. A worker had been injured and was possibly now deceased. Members and EMS attended the scene where the male was pronounced as deceased. Workplace occupational health and safety and Provincial occupational health and safety personnel were onsite and investigating. Members investigated. No criminality or foul play are suspected in the death. Autopsy was ordered by the coroner and results are pending. File 2024-1701717 refers.

- 2- On December 13<sup>th</sup>, White Butte members were called to a rollover on Highway # 1 east of the city where the bypass/overpass meets Highway # 1. The occupants left the scene of the accident and were reportedly given a ride to the Boston Pizza in Emerald Park by a passer by. Members attended the scene and started to investigate. The people witnessed leaving the scene were identified at Boston Pizza. The investigation yielded charges against a 32-year-old Jade MOSES of Regina for failing to comply with release order condition 145(5)(a) Criminal Code. In addition, a 26-year old Skyler WILLIAMS of the Pasqua First Nation was charged with failing to comply with release order condition 145(5)(a) and Resist/obstruct peace officer 129(a) Criminal Code. File 2024-1813125 refers.
- 3- On December 24<sup>th</sup>, White Butte members were called to a motor vehicle collision in the Town of White City of a pickup truck stuck up against a barbed wire fence with a male laying back in the driver's seat. Members attended the scene to investigate. The truck turned out to be a stolen vehicle. The male was arrested for possession of stolen property and remanded. At the same time as members were investigating this file a complaint cam in about a theft of two frost fighters being stolen from Avena Foods south of the city, a couple of nights ago. The complainant was able to get video footage to members right away of the suspect/s and vehicle involved. Upon review of the footage it was obvious the suspect vehicle was a match to the vehicle that was stuck up against the fence. 39-year-old Aaron OLNEY of Carievale Saskatchewan was charged with possession of property obtained by crime over \$5000.00 Section 354(1)(a) Criminal Code and theft over \$5000.00 Section 334(a) Criminal Code. File 2024-1862375 and 2024-1862847 refers.
- 4 On December 30<sup>th</sup>, White Butte members received a call to the Town of Pilot Butte for a wellness check concern. The complainant was asked to check in on an adult male by the mother and father who were away vacationing at the time down south. The complainant had keys for the residence and let themselves in to check on the adult male. The male was found unconscious in the residence and was pronounced deceased. No foul play is suspected and the family is proceeding with funeral arrangements. File 2024-1885866 refers.
- 5 On January 6<sup>th</sup>, White Butte members were called to a residence in the RM of Edenwold where a family dispute was occurring. Members attended the scene and started to investigate. Two males were assaulting each other with weapons. 28-year-old Caleb THOMPSON of Regina/Balgonie was charged with two counts of failing to comply with release order condition Section 145(5)(a) and aggravated assault Section 268(2) Criminal Code. 31-year old Christian THOMSON of Regina/Balgonie was charged with assault with a weapon Section 267(a) Criminal Code, uttering threats Section 264.1(1)(a) Criminal Code and fail to comply with probation order Section 733.1(1) Criminal Code. File 2025-25483 refers.
- 6 On January 8<sup>th</sup>, White Butte members were called to a family dispute in the RM of South Qu'Appelle of a woman advising her boyfriends mother was in a conflict with her over the wellbeing of her child. As police were getting to the scene it was further learned that there was an assault between the woman and her boyfriend. Members investigated the incident. A 23-

year old Keely HASSMAN of Emerald Park was charged with assault Section 266 Criminal Code. A 21-year old Lucas GRAFF was charged with assault Section 266 Criminal Code. File 2025-32319 refers.

- **#4. RPCC Investigations:** 1 mental health act, 3 assaults, 1 being unlawfully at large and 22 assistance files. Total for the reporting period is 27.
