Town of Grand Coulee Community Update

June 2026

Hello Grand Coulee Residents,

As we move into the summer season, we would like to share several important updates and announcements from around the community.

Property Tax Notices

The 2026 property taxes have now been levied.

Residents who utilize the Town's customer portal can access their tax notices through their portal accounts. Residents who receive notices by mail can expect to receive their tax notices within approximately one week.

Dust Control Program

The Town's annual dust control program is loosely scheduled to take place in mid-June. The same dust control methods that were successfully utilized in 2025 will be used again this year.

An exact application date has not yet been finalized. Residents are encouraged to monitor the Town website and Facebook page, where scheduling information and additional details will be posted once finalized.

Water Main Break and Precautionary Drinking Water Advisory

Earlier today, the Town experienced a water main break that required immediate repairs.

As a result, residents on Fairfax Street and all areas west of Fairfax Street experienced a disruption in water service for much of the day. Residents throughout the remainder of the community may have noticed reduced water pressure while repairs were underway.

Repairs have now been completed; however, as a precaution, residents who experienced a water outage today (those located on Fairfax Street and west of Fairfax Street) are under a Precautionary Drinking Water Advisory until further notice.

Additional information regarding the advisory will be provided as it becomes available.

The Town would like to thank residents for their patience and understanding while Public Works crews worked to restore service.

Customer Portal Notifications

We continue to experience issues with customer portal notifications not being delivered consistently.

Town administration is actively working to resolve these issues; however, the situation has proven to be more complicated than anticipated. Challenges include issues related to SaskTel email services, as well as difficulties obtaining access to legacy account information required to fully resolve the problem.

We appreciate your patience as we continue working with service providers and software vendors to find a permanent solution.
