#1. White Butte Detachment Staffing Update:

-S/Sgt. Detachment Commander, Sgt. Operations NCO and Cpl. Supervisor NCO positions are all filled at this time.

-Constable vacancy. Cst. Sarah Gamache from Dauphin Detachment in Manitoba has been transferred and will be arriving this summer.

- All other Constable positions at this time are filled.

#3. Calls of Interest:

 $1 - On May 21^{st}$, White Butte Detachment received a call on McKenzie Landing in White City. There was an apparent neighbour dispute over some fence boards that were put up. The adjoining neighbour tore the boards down on two different occasions. Members attended the scene and spoke to all parties involved. Subsequent investigation was completed and the neighbour that tore the boards down was charged with mischief and uttering threats. The accused is Jesse Thurmeier. He has court on June 28th in Regina. File 2023-699354 refers.

2– On May 27th, White Butte received a call of a single vehicle rollover in the RM of Sherwood. Member attended to the scene with Regina EMS and Regina Fire to determine that drugs was a possible factor in the cause of the rollover. The person was taken to the Regina General Hospital for treatment. Members drafted a search warrant for the blood to be seized given the person's condition. The blood was seized by members and is being examined by the lab to determine the level of intoxication. Charges are pending against the person. File 2023-735871 refers.

3- On May 31st, White Butte members were on patrol in the Town of Balgonie around lunchtime when they saw a John Deere Gator driving down Highway 364 in the driving lane. Members pulled the Gator over to find that the driver was suspected to be impaired by alcohol. Members conducted an investigation of impaired driving and have charged 49 year old Derek McIlwaine with impaired driving and refusal to comply with demand. File 2023-756896 refers.

4- On May 31st, White Butte members started a file on a matter stemming out of White City involving a resident that has lodged several complaints of ATV's driving around needlessly. The RCMP have met with the complainant and the investigation is ongoing. Neighbourhood inquiries have shown that the problem appears to be isolated to the perception of the complainant alone. Members remain committed to working with the complainant to subside some of the concerns. File 2023-757650 refers.

5- On June 6th, White Butte members received a call of a sexual assault in the Town of Lajord. The assault happened a couple of years ago between an adult and a child that did know each other. Due to the sensitive nature of the investigation limited details will be available to the public. The investigation is at the beginning and statements are still being collected to determine if and what charges are warranted. File 2023-794914 refers.

6- On June 8th, White Butte Detachment received a call to the Finning / CAT dealership on the North end of Regina on Highway 11 and Pasqua Street. There was a female in the parking lot going through employees' personal vehicles with no shoes on. One of the vehicle owner's that was being stolen from confronted the female and an assault occurred. Members arrived on scene and arrested the female. Investigation was completed and 29 year old Summer Favel was charged with assault and mischief. File 2023-802330 refers.

7- On June 9th, White Butte Detachment was called to assist Outlook and Lumsden Detachments with a file that involved a male who was dangerous driving and appeared to be heading towards Regina. The White Butte member became involved with the vehicle around the area of Highway 11 and Exit A. Members attempted to have the vehicle stop. Members ended up using a spike belt at one point. RPS Air 1 was assisting as well. The male was eventually arrested in the City of Regina by RCMP and 30 year old Joel Girard was charged with flight from peace officer and dangerous operation of a motor vehicle. File 2023-813988 refers. **#4. RPCC Investigations.** 1 assault with a weapon, 1 CDSA, 3 possession of a weapon, 1 assault and 15 assistance files. The total for the reporting period is 21.
