#### #1. White Butte Detachment Staffing Update:

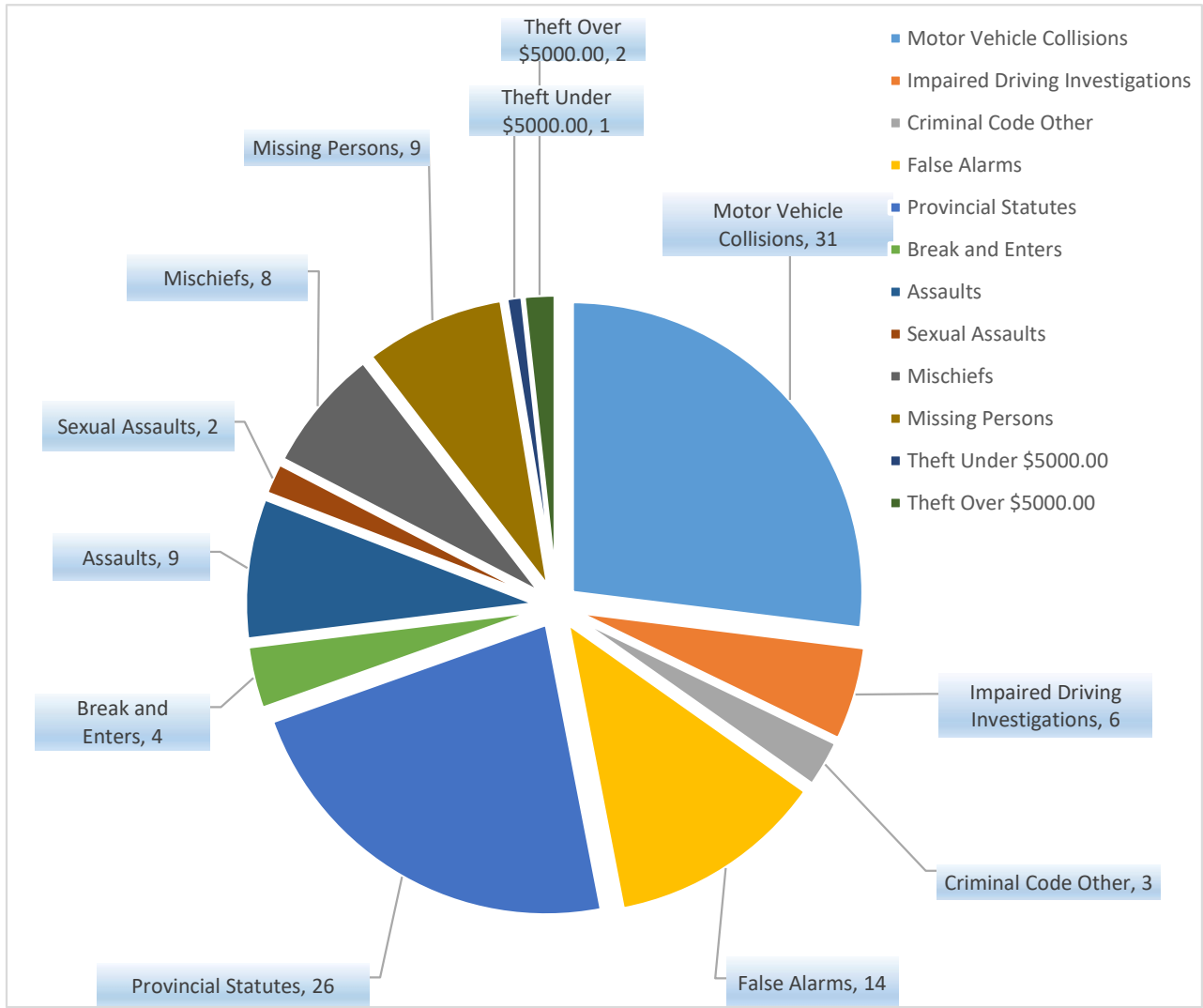
- S/Sgt. Detachment Commander position is filled at this time.
- Sgt. OPS NCO position is currently vacant. A transfer has been issued for Sgt. Steven Ross from Estevan Detachment due to arrive, once his house is sold.
- Both Corporal positions are filled at this time.
- White Butte has four Constable vacancies. A Constable for Rinholm's old spot. A Constable for Ubell's old spot. A Constable for Gamache's old spot. A Constable for Spasoff's old spot.
- Staffing advised White Butte will be getting a Cadet from Depot at the end of March, 2025.
- Staffing advised that White Butte will be getting a member from the EPOP. White Butte is very excited to hear this news and we could see him in the next month!

#### #2. Calls for Service: Analysis last 28 days (February 20, 2025 to March 20, 2025)

- Total of 945 occurrences generated.

**#3. Calls of Interest:**

1 – On February 21<sup>st</sup>, White Butte members received a call to the Emerald Park, Sobey’s Liquor store on South Plains Road. The complainant called to report that there was a suspicious person that followed them into the store. The complainant left the store and that same person then followed them around Emerald Park and White City by way of vehicle. The suspicious person was driving a blue car. At one point the suspicious person told the complainant that they were going to kill them. The complainant does not know who the suspicious person is. Members started to investigate and only had a partial licence plate number. Security video was

obtained from Sobey's Liquor. Members have now identified the suspect and charges are forthcoming to a 48 year old person from Regina. They are being charged with uttering threats against a person Section 264 Criminal Code. File 2025-234626 refers.

2- On March 1<sup>st</sup>, White Butte members received a call to the Ramada Hotel in Emerald Park. There was a male that was intoxicated and was knocking on other guests' doors. The male then forced his way into a hotel room and was talking to three young girls who were only dressed in their bathing suits. Members attended the scene and arrested the male who was resisting members. 57 year old Joseph Piapot was lodged in cells and is facing charges of breaking and entering with intent – residence Section 348 Criminal Code, fail to comply with probation order Section 733 Criminal Code, mischief under \$5000.00 obstruct enjoyment of property Section 430 Criminal Code and resist/obstruct peace officer Section 129 Criminal Code. File 2025-273260 refers.

3- On March 8<sup>th</sup>, White Butte members were advised to be on the look out for a white Jeep that failed to stop for Regina Police Service in the City of Regina. The RPS police plane was on duty and in service and was able to follow the suspect vehicle from the air. The suspect vehicle was heading east from the city and was abandoned in a rural area near the Town of Balgonie. RCMP members did not pursue the suspect vehicle at any time. At the abandoned vehicle members converged and employed multiple members and police dog services resulting in arrests of a 31 year old female and a 36 year old male from the Estevan area. Regina Police Service has charged Angella Chouinard with multiple firearms offences, resisting a police officer, possession of property obtained by crime and failing to comply. Regina Police Service has charged Kyle Loubier with multiple firearms offences, flight, dangerous operation of a motor vehicle, failing to comply and possession of property obtained by crime. File 2025-307135 refers.

4- On March 9<sup>th</sup>, White Butte members were called to a residence in the Town of Pilot Butte. Caller reporting a 15 year old was being assaulted by his father at the family residence. The son had sustained visible injuries. Members attended the scene and started to investigate. Statements were taken from all witnesses as well as the victim and the SOC. Members ended up arresting the 39 year old male and charging him with assault against his son. File 2025-311156 refers.

5 – On March 11<sup>th</sup>, White Butte members were called to a suspicious person at the weigh scales on eleven highway north west from the City of Regina. The caller was in their semi and heard a knock on the door. The female said that she was frozen and needed to warm up. The female advised she was getting a ride from Regina to the Saskatoon area but she got kicked out of the vehicle. Members attended the scene and started to investigate. The file is still open, pending new information. File 2025-316631 refers.

6 – On March 18<sup>th</sup>, RCMP roving traffic unit were working in the Regina area on Highway # 1. The unit completed a roadside stop on an SUV. Indicators were observed of a travelling criminal. PDS was utilized and indicated positive. A search was conducted of the vehicle and

illegal drugs were located and seized. A 41 year old male Jalil Wahab was arrested and charged with trafficking a schedule 1 substance and possession for the purpose of trafficking schedule 1 substance Sections 5(1) and 5(2) of the Controlled Drug Substances Act. File 2025-352310 refers.

**#4. RPCC Investigations:** 1 false alarm, 3 assaults, 1 being unlawfully at large, 2 possession of drugs and 11 assistance files. Total for the reporting period is 18.
