## **#1. White Butte Detachment Staffing Update:**


- -S/Sgt. Detachment Commander and Sgt. Operations NCO positions are filled at this time.
- -Cpl. Tyson Greig has been promoted to the L.A.S.T. at "F" Division HQ which has created one Cpl. vacancy at this time. We are currently running a competition for promotion to find a replacement.
- -Cpl. Travis Davidson has been transferred to Depot Division which will create a second Cpl. vacancy. A lateral replacement has been found and transferred. His name is Cpl. Derek Haines from Big River Detachment. Once he sells his house, we should have a start date. Welcome to the team!
- Cst. Nicole Peddigrew has been transferred here from Yorkton Detachment, her house has sold at origin.

#### #3. Calls of Interest:

1 – On April 26<sup>th</sup>, White Butte members received a call for assistance from the Saskatchewan Highway Patrol at the Highway 11 weigh scales. They had a semi at the scales that was suspicious and Saskatchewan Highway Patrol had searched the semi during the course of their investigation. Two males were under arrest due to the search. White Butte member attended to the scene to assist with the investigation. The investigation revealed a large sum of cash that was seized from the two occupants of the semi. 52 year old male from Mississauga Ontario will be charged with proceeds of crime offences under the criminal code. A 58 year old

male from Ancaster Ontario will be charged with proceeds of crime offences under the criminal code. File 2024-552730 refers.

- 2 On May 6<sup>th</sup>, White Butte received a complaint of a break and enter to a business on the outskirts of Regina. The complainant advised that the building was currently under construction and there were no video cameras even installed yet. The complainant was working on the building and arrived to work at 0830 that date. Members attended to the scene and were advised that about \$70,000.00 worth of tools and copper wire were stolen. There was a break in nearby to another building about five years ago. There was no security footage. The investigation continues. File 2024-603665 refers.
- 3- On May  $6^{th}$ , White Butte received a call to the Shoppers Drug Mart in Emerald Park. Members were responding to a complaint of shoplifting electronics from the store. The store manager provided the members with security footage and they had totaled the theft to be around or just over \$1000.00. The manager also had realized that this was the same suspect as a theft from days earlier on May  $3^{rd}$ . The amount of electronics stolen that day as well was around \$1000.00. Members have been investigating the file and have identified a suspect from Regina who will be charged with two counts of theft under \$5000.00 under the criminal code. File 2024-604681 and 2024618028 refers.
- 4- Over the last month members have been working with many of the schools in the area conducting school presentations to elementary school students on various topics such as: social media safety, sexting, bullying, cell phone safety, cyberbullying and bicycle safety. The schools have been from all across the Detachment area.
- **#4. RPCC Investigations.** 2 assaults, 2 being unlawfully at large, 1 fail to comply, 1 sexual assault and 12 assistance files. The total for the reporting period is 18.
