#1. White Butte Detachment Staffing Update:

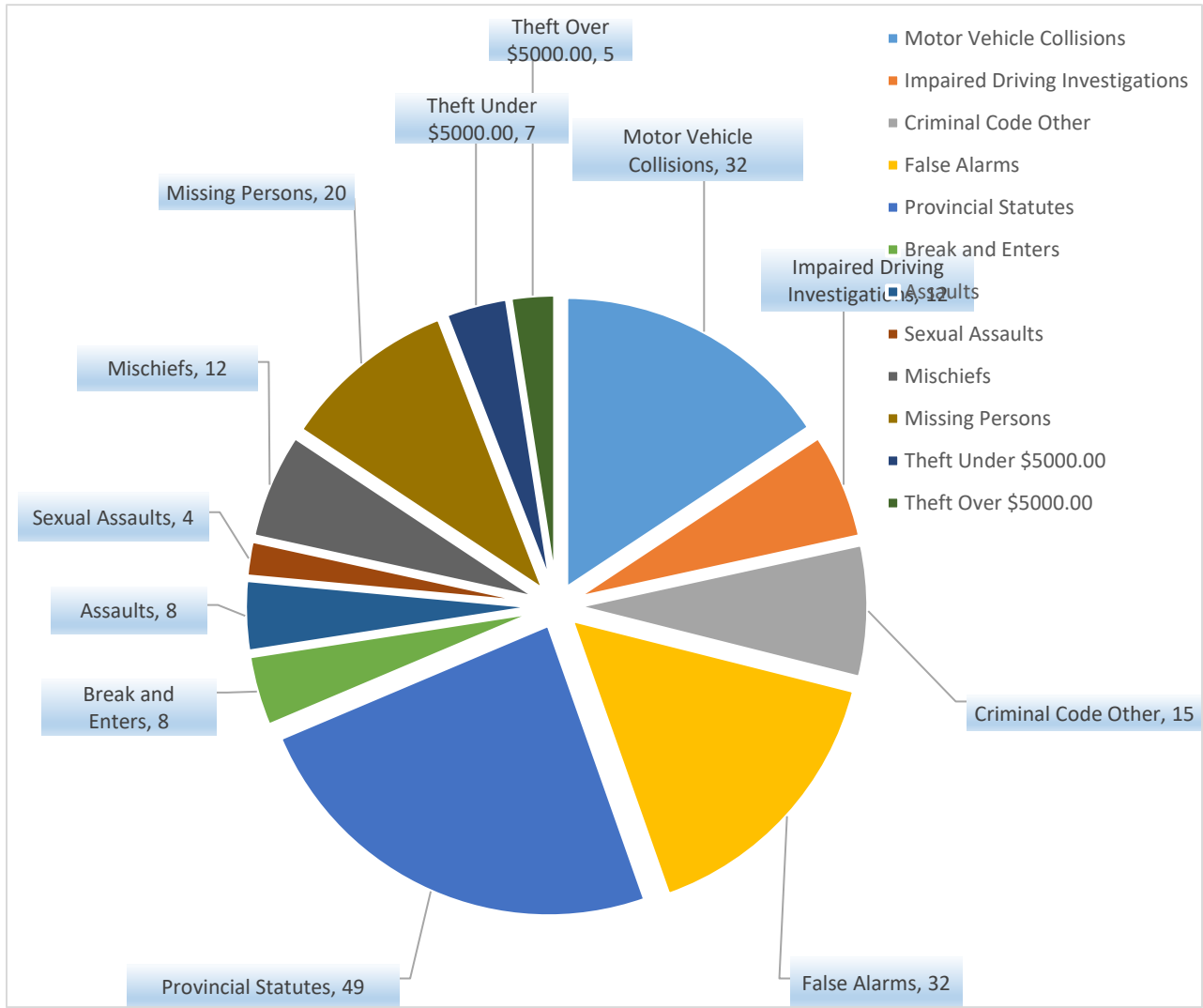
- S/Sgt. Detachment Commander position is filled at this time.
- Sgt. OPS NCO position is currently vacant. A transfer has been issued for Sgt. Steven Ross from Estevan Detachment due to arrive, once his house is sold.
- Both Corporal positions are filled at this time.
- Cst. Kimberly Flett has been transferred and will be joining us from Yorkton RCMP on December 9th, 2024.
- Staffing is working on finding White Butte, three Constable members to be transferred in. A Constable for Rinholm's old spot. A Constable for Ubell's old spot. A Constable for Gamache's old spot.

#2. Calls for Service: Analysis last 35 days (October 17, 2024 to November 21, 2024)

#3. Calls of Interest:

1 – On October 23rd, White Butte members received a call from a person advising that their shop and some outbuildings were broken into overnight on a rural property in the RM of Sherwood just off of the number 6 Highway. Stolen from the property was a skid steer bobcat, two trailers (one flat deck and one utility) and two quads. Members from the White Butte Detachment attended the scene to investigate further. All items with serial numbers have been added to CPIC as being stolen. The investigation continues. File 2024-1566092 refers.

2- On October 27th, White Butte members were called to a residence in the Pilot Butte area for a theft. The complainant was a corrections officer who advised their vest and complete duty belt had been stolen. Members attended the scene and started to investigate. Camera footage / video and still images are being sought, examined and followed up on. File 2024-1588392 refers.

3- On October 31st, White Butte members were called to the Sobey's Liquor store in Emerald Park. The report was that two males came into the store and they took a couple 40 oz bottles of rum. Members attended to investigate. Members have a very good description of the males and are following up on the vehicle information provided as well. Video footage to be acquired and reviewed as well from the business. File 2024-1609149 refers.

4 – On November 2nd, White Butte members received a 911 call of impaired driving in the RM of Edenwold on the Frankslake Road near the service road. The suspect vehicle cut the complainant off and then went into the ditch. Members attended to the scene. Members immediately suspected the driver was driving while impaired. 40-year-old Everell SHAVIK from Pilot Butte has been charged with Section 320.14(1)(b) operation while over 80mg% of a motor vehicle and Section 320.14 (1) (b) operation while impaired by alcohol of a motor vehicle. File 2024-1620576 refers.

5 – On November 11th, White Butte members were called to the RM of Sherwood on the West side of Regina. There was a break enter and theft of a welder, hand tools and related equipment. Members attended the scene and started to investigate. No suspects. Video footage is available from Cargill. File 2024-1663423 refers.

6- On November 12th, White Butte received a complaint from a local business in Emerald Park that sells agricultural equipment and supplies. The report was of a fraud taking place over the purchase of a brand-new bale picker for \$60,000.00. The members are still investigating the file to determine the elements of the offence. File 2024-1667788 refers.
