#1. White Butte Detachment Staffing Update:

-S/Sgt. Detachment Commander, Sgt. Operations NCO and Cpl. Supervisor NCO positions are all filled at this time.

-One Cst. position is vacant. Cst. Jason Willette has been transferred into the Detachment from Regina Major Crimes. The Detachment is very excited to have his experience and service at the Detachment here in White Butte. He is set to arrive with in the month.

#2. Calls for Service – Analysis last 28 days (October 19, 2023 to November 16, 2023)

#3. Calls of Interest:

1 - On October 23rd, a White Butte member was out on patrol and observed a vehicle going through a red light, then it made a U-turn at an intersection along Victoria Avenue. The member pulled the vehicle over. Alcohol could be smelled from the driver of the vehicle. When the driver was asked for his vehicle registration he provided the member with a receipt for a wheel alignment. The member proceeded with an impaired driving investigation. 43 year old Andrew Kinnell was charged with impaired driving and driving with over 80mg% alcohol. File 2023-1581191 refers.

2 - On October 24th, White Butte Detachment was dispatched to a call of a motor vehicle collision on Highway 33 near the Town of Kronau. There was reported to be a non responsive 20 year old female involved. Members attended to the scene and were able to determine that a semi and an SUV collided with each other. The driver of the SUV was the non responsive female. There was a fresh snowfall and the roads were ice and snow covered and were very slippery. Travel was not recommended at the time. Members found out that EMS had declared the female as deceased. Further investigation revealed that road conditions were the major contributing factor in the cause of the collision. No criminal charges emerged during the investigation. File 2023-1582540 refers.

3 - On November 2nd, White Butte members were dispatched to a file in The Town of Balgonie. The complainant reported that their house was broken into while they were sleeping. After review of the cameras it appeared that a male was hanging out in their back yard around midnight. The male then entered the house around 0100 and came in through the back door. Once inside the house he ate a pizza from the fridge / freezer. A short while later the male left after taking a jacket from a closet. Members have been investigating the file and have a suspect identified for the break and enter. File 2023-1631245 refers.

4 - On November 12th, White Butte Detachment received a dispatch to a complaint of an erratic driver on 1 Highway West bound at the town of McLean. Member located the vehicle and pulled it over. Upon investigation it was noted there was a large sum of cash in plain site.
Further investigation resulted in members arresting two males for suspected drug trafficking.
32 year old Harley Sinclair has been charged with driving while disqualified, possession for the purpose of trafficking and possession of property obtained by crime over \$5000.00.
39 year old Jeremiah Sinclair has been charged with possession for the purpose of trafficking, possession of property obtained by crime over \$5000.00 and possession of drugs. File 2023-1677117 refers.

5 - On November 14th, White Butte Detachment learned that three of our own members would be receiving the Van de Vorst Award for the period of April 2022 to March 2023. The Van de

Vorst awards are given to officers that investigated at least eight impaired operation files that resulted in charges. This award honours the memory of the Van de Vorst family, tragically killed in early 2016 as a result of a motor vehicle collision on the outskirts of Saskatoon. Parents Jordan and Chanda died on scene and their two children, Kamryn and Miguire, died later in hospital. All of the work members do to make our roads and highways safer helps to ensure this same kind of tragedy doesn't strike more Saskatchewan families. A formal awards presentation ceremony will be organized and hosted by MADD in partnership with SGI. Recipients from White Butte are Cst. Nolan Rinholm, Cst. Jennifer Collins and Cst. Andrew Zaichkowsky
