#1. White Butte Detachment Staffing Update:


- -S/Sgt. Detachment Commander position is filled at this time.
- Sgt. OPS NCO position is currently vacant as Sgt. Lee Knelsen has been transferred to Prince Albert. The new Sgt. has been named and a transfer has been issued for Sgt. Steven Ross from Estevan Detachment due to arrive in the fall.
- -We are currently finalizing a competition for promotion to find a replacement for one of the Cpls. The process is in the final stages of selection, where the winning candidate will be named.
- Cst. Andrew Zaichkowsky had his last day on September 2nd. Staffing has identified a replacement and they have been transferred.

#3. Calls of Interest:

1 – On June 8th, White Butte members received a complaint from a Saskatchewan Provincial Corrections Officer that a former inmate was communicating with them in an unwanted manner through their incarceration at RPCC via social media. Members investigated further and were familiar with the suspect due to other similar occurrences from the recent past while. On previous files the suspect has been charged and convicted under the criminal code. The file is currently becoming more complex and involves many victims. File 2024-790121 refers.

- 2 On July 24th, White Butte received a complaint from the Town of Balgonie of someone spraying graffiti on several locations around town and at Greenall High School. Members started their investigation and canvassed the community to identify the suspect using the video footage received. Members learned the identity of the person responsible for the damage. The person was spoken to and they have admitted their involvement to police. Arrangements have been made to have the damages paid for/repaired by the person responsible. The RCMP thank the community for their assistance with the investigation. File 2024-1053479 refers.
- 3 On August 19th, White Butte received a call from the Town of Pilot Butte where a resident reported that their expensive bicycle had been stolen. There may be video footage of the incident from their neighbours doorbell / ring cameras. There had also been a lot of construction occurring around town and maybe one of the workers took interest in the bicycle. Members investigated further and partnered up with RPS to identify and arrest the suspect. The bicycle was recovered. The suspect charged was 25 year old Jamie Dawson HARRIS of Regina with possession of property obtained by crime. File 2024-1206632 refers.
- 4- On August 24th and 25th, White Butte Detachment was called to an underpass/bridge on the Regina Bypass of a suspicious male hanging around. Members attended to the scene and found the male perched up in the rafters and he was not willing to come down at the request of police. The male appeared to be in mental health distress. Members finally were able to talk the male down and took him to mobile crisis in Regina. File 2024-1238000 and 2024-1241442 refers.
- 5- Over the last month White Butte Detachment has seen an increase in missing persons complaints with in the Detachment area. For example there has been 11 high risk missing youth reported to police as missing. File 2024-1241073 refers.
- 6- On September 10th, White Butte Detachment has been working with lawyers and two families on a domestic dispute / disagreement / divorce. The matter stems from the Pilot Butte area. Police have assisted to keep the peace on several occasions during the divorce / separation proceedings. File 2024-1333035 refers.
- 7- On September 15th, White Butte Detachment received a complaint at the IGA grocery store in Emerald Park. Two adult males approached two youth who were shopping at the store for some pop. They initiated conversation and asked them to come out to their vehicle to meet a YouTube personality. The youth did not oblige the request and wanted the strange encounter reported for information at this time. Investigation revealed no apparent criminality. File 2024-1377457 refers.
- **#4. RPCC Investigations.** 1 assault, 1 criminal harassment, 1 911, 1 failure to comply, 1 possession of a weapon and 12 assistance files. Total for the reporting period is 17.
- **#5. Round table:** 1) Letter dated September 5, 2024 from a rate payer about golf cart use in relation to Aspen Links Golf Course. 2) Active fraud file from Pilot Butte.
