#1. White Butte Detachment Staffing Update:

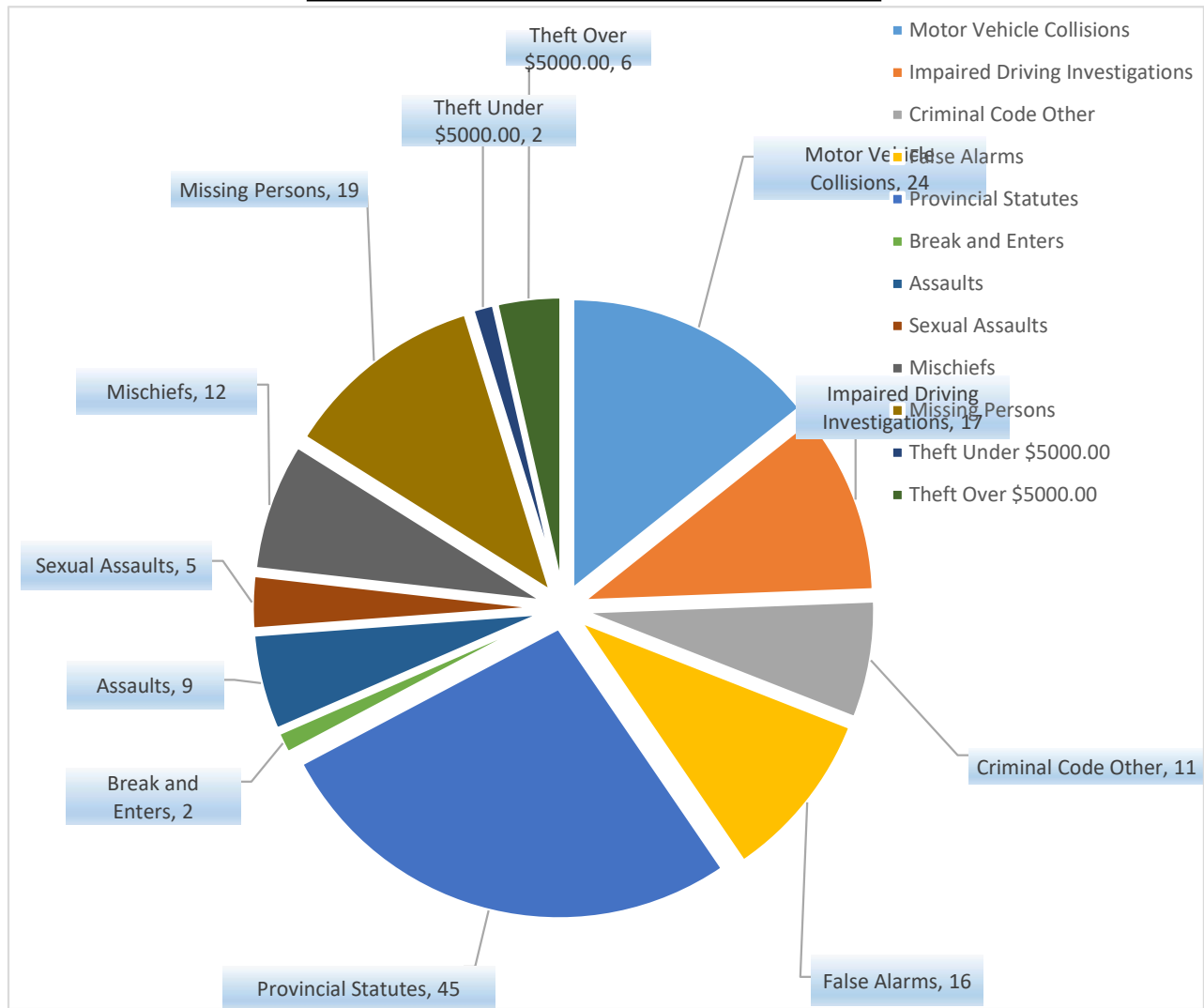
- S/Sgt. Detachment Commander position is filled currently.
- Sgt. OPS NCO position is filled currently. Sgt. Steven Ross has started on June 4th, 2025.
- Both Corporal positions are filled currently.
- White Butte has two Constable vacancies.
- One Cst. has been transferred, sold his house and is due to arrive in early July.
- One Cst. will be receiving their transfer notice on or around July 1st. They will be here in early August sometime.

#2. Calls for Service: Analysis last 35 days (May 15, 2025 to June 19, 2025)

#3. Calls of Interest:

1 – On April 15th, White Butte Detachment received a complaint from a male stating that his ex-wife has been making false complaints, about him, to the RCMP for quite some time now and wanted to provide a statement to that effect. The RCMP have met and worked with the male and the female several times recently. On several occasions the male was reported by the female as being the instigator. Further investigation now leads officers to believe that the female has been committing the offence of public mischief. The investigator has been working diligently to bring the file to the laying charges stage. File 2025-493180 refers.

2 – On June 4th, White Butte members received a complaint from a male in the detachment area that 2-3 years ago his ex-wife forced him to have sexual relations with her and while doing so she stole his semen in efforts to become pregnant. Members are investigating the file which as it turns out is related to a serious domestic assault file from a couple of months ago. File 2025-775539 refers.

3 - On June 8th, White Butte members were dispatched to a call for service to a youth facility near Pilot Butte at Jordan House. The staff there were reporting that they needed assistance for what they described as an “unsafe situation”. Half of the youth residents were in an uproar, and it now seems they have turned on the staff displaying riot mentality. RCMP members attended to the scene and spoke to all parties involved. The youth involved wanted to push past the staff and run away. The youth were separated and de-escalated by the police for the evening. No assault actually took place. File 2025-797079 refers.

4 – On June 11th, White Butte members were dispatched to a rural property near Grand Coulee for a call of domestic violence. A male and female were fighting and there was possibly alcohol involved. The male was attempting to strangle the female and assault her. Members attended to the scene and began to investigate the situation. Members arrested 38-year-old Caleb HEENAN for assault. Caleb was charged with Section 266 assault, Section 267(a) assault with a weapon, Section 145(5)(a) and (b) fail to comply with release order conditions. File 2025-814583 refers.

5 – On June 15th, White Butte members were called to a traffic complaint on Highway # 1 near Pense. The caller advised that they were behind a car that was straddling the lanes and going 50 km/hr in a 110 km/hr zone. The driver appeared as an intoxicated female driver. Members headed to the scene to conduct a patrol of the area. Members located the vehicle on the Highway # 1 which was parked at the time and the female driver was asleep and the male passenger was asleep as well. Members completed their investigation and arrested and charged both with multiple criminal code offences. 39-year-old Angela CURRIE of Regina was charged with Section 320.14(1)(a) operation impaired by drug, Section 354(1)(a) possession of property obtained by crime over \$5000.00, Section 403 identity fraud, Section 368(1) possess a forged document, Section 354(1)(a) possession of property obtained by crime less than \$5000.00 X 2. 53-year-old Jason DEVINS of Calgary was charged with Section 354(1)(a) possession of property obtained by crime over 5000.00, Section 354(1)(a) possession of property obtained by crime less than \$5000.00 X 2, Section 368(1) possess a forged document X 2, Section 145(5)(a) fail to comply with release order condition X 5, Section 129(a) obstruct public officer. File 2025-833532 refers.

6 – On June 15th, RCMP members were on patrol out on Highway # 10 near Edgeley. The member observed a vehicle going towards Regina at a very high rate of speed. The radar confirmed they were going 188 km/hr. Members pulled the vehicle over and arrested the driver for dangerous operation. 18-year-old Dayton PINAY from Balcarres was charged with

Section 320.13(1) TSA dangerous operation of motor vehicle and had his vehicle impounded.
File 2025-834048 refers.

#4. RPCC Investigations: 2 assaults, 1 possession of weapon for a dangerous purpose, 2 sexual assaults, 1 possession for the purpose of trafficking and 9 assistance files. Total for the reporting period is 15.
