#1. White Butte Detachment Staffing Update:


- -S/Sgt. Detachment Commander position is filled at this time.
- Sgt. OPS NCO position is currently vacant. A transfer has been issued for Sgt. Steven Ross from Estevan Detachment due to arrive, once his house is sold. Update, his house sold and possession date is the end of May. We should see him here in White Butte in early June.
- Both Corporal positions are filled at this time.
- White Butte has two Constable vacancies.
- Our new Cadet from Depot started on Saturday April 12, 2025. Welcome Cst. Ramin Tajik.
- White Butte is very excited to also welcome Cst. Chris Lamarche formerly from the Ottawa Police Service. He will be starting the week of April 28th once his conversion training has been completed. The training goes from April 7th -25th.

#3. Calls of Interest:

1 – On March 25th, White Butte members were called to the Balgonie Elementary School by the Principal. Over the lunch hour one of the students brought to school and produced an air soft pistol and threatened another student with it. This occurred right in the classroom during lunch. The student was now located in the principal's office. The principal had seized the air soft pistol from the youth. Parents had been notified by the school to attend the scene. Members attended the scene and started to investigate. No charges were laid due to the age

of the youth. The RCMP are working with the family to ensure safety for all of the students. File 2025-387722 refers.

- 2 On April 1st, White Butte members were called to a residence in the Town of White City. A female victim reported that her husband assaulted her. This happened because he was trying to get his cell phone back from her. Physical evidence was present from an assault. Members arrested 33 year old Dylan Cappelle of White City and charged him with multiple offences: assault, forcible confinement, uttering threats, overcoming resistance to the commission of an offence and sexual assault. File 2025-419170 refers.
- 3 On April 4th, White Butte members were called to the Balgonie Motel, room # 4. Members were advised that a 60 year old male had medical concerns / chest pains and was intoxicated and being aggressive with medical first responders. Members attended the scene and witnessed the male refusing to go to the hospital with medical personnel. Members started to investigate the male's identity. Turns out the male was wanted and had a multiple warrants of arrest in locations all across Canada. Members charged 60 year old Matthew Bell with 2 counts of adult fail to comply with release order condition, 1 count of adult fail to comply with undertaking condition and 1 count of adult resist /obstruct peace officer. File 2025-440382 refers.
- 4 On April 8th, White Butte members received a call to the North Industrial Park, just north west from of the City of Regina. The report was that there was a man down at a business called T Doyle Transport. The supervisor attended to the business in the morning and witnessed a male outside his semi on the ground showing signs inconsistent with life. Members attended the scene and started to investigate. No criminality or foul play was suspected. NOK was completed with multiple family members. File 2025-456170 refers.
- 5 On April 10th, White Butte members received a call to be on the lookout for a vehicle suspected of involvement in a recent homicide from the City of Regina. Information was received that the suspect vehicle may now be heading towards Saskatoon on Highway # 11. Multiple police units worked in conjunction with the Regina Police Service aircraft to locate and keep an eye on the suspect vehicle. Members diligently followed from a distance and the suspect vehicle ended up in the Town of Davidson. A high risk takedown was utilized in apprehending and arresting all parties involved. No officers were injured in the incident. RPS is taking carriage of the main file. File 2025-466221 refers.
- 6 On April 17th, White Butte members were dispatched to a single vehicle rollover on the Bypass NW of the City of Regina on the ramp to Highway # 11. Members arrived on scene and started to investigate. There was one occupant of the vehicle that was deceased. The other/s involved were taken to the hospital for treatment. The coroner attended the scene as well as the RCMP traffic analyst. The investigation is underway and criminal charges may be forthcoming. File 2025-502906 refers.

#4. RPCC Investigations: 2 assaults, 1 possession of weapon, 1 aggravated assault and 7 assistance files. Total for the reporting period is 11.
