#1. White Butte Detachment Staffing Update:

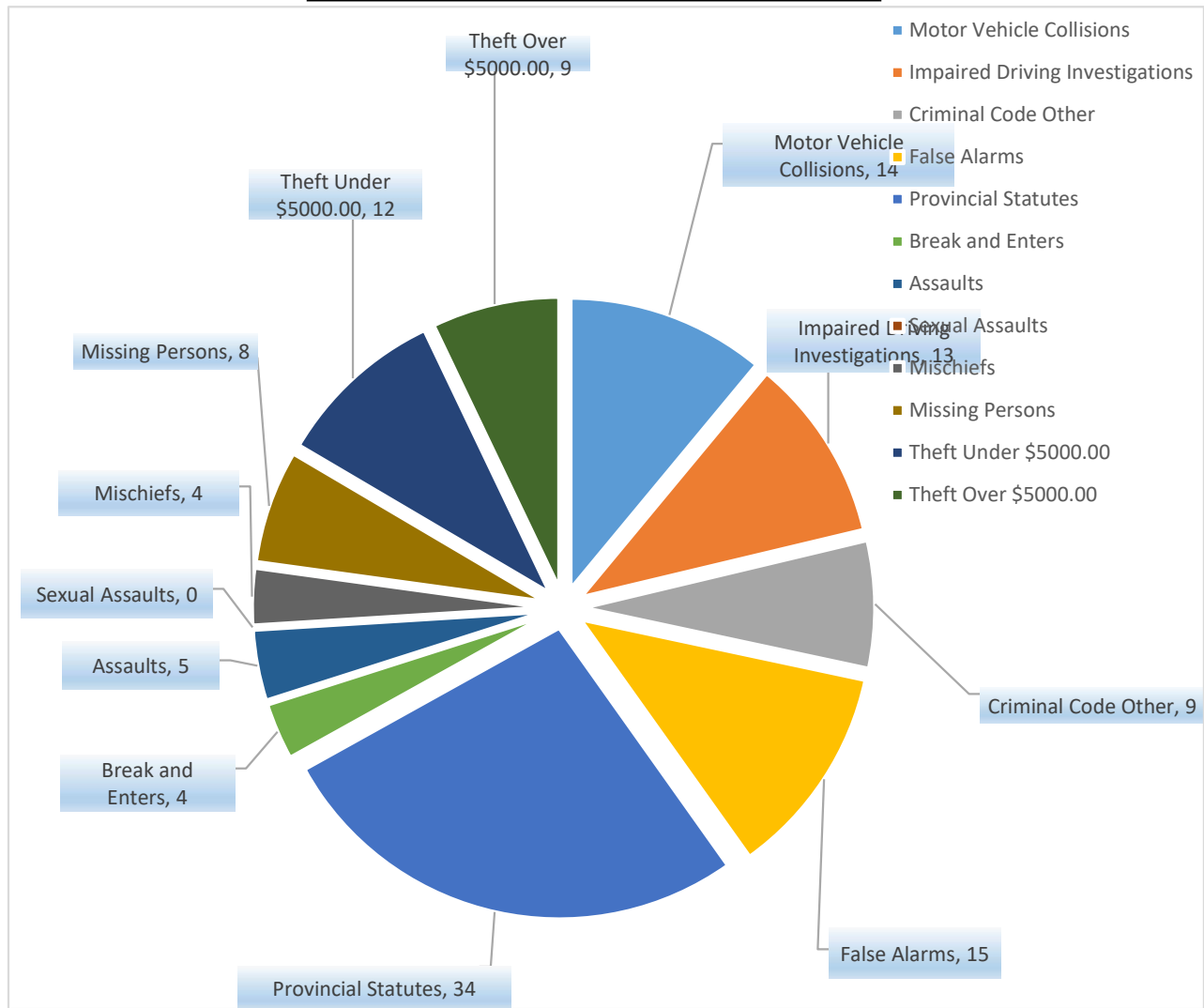
- S/Sgt. Detachment Commander position is filled currently.
- Sgt. OPS NCO position is filled currently.
- Both Corporal positions are filled currently.
- White Butte has one Constable vacancy currently.
- A new Cst. has started working at the Detachment on September 2nd, 2025. The Detachment welcomes Cst. Mark Sabo. We are extremely excited to have him as part of the team!

#2. Calls for Service: Analysis last 28 days (August 21, 2025 to September 18, 2025)

- Total of 1190 occurrences generated.

#3. Calls of Interest:

1 - *****Original:** On July 21st, White Butte Detachment received a complaint from a victim couple advising they have received threats against their business and their family. Multiple threats have been coming to them through various social media platforms. RCMP have been working hard to identify persons of interest. Suspects have been interviewed, and police believe that there are currently now two persons of interest attached to the file. Members have been writing search warrants and production orders in efforts to bring the file to a charge stage. Security measures have been established as well as safety planning with the couple.

White Butte has additionally been working with task forces in British Columbia and Ontario as partners in this very large-scale investigation. *****Update:** Members have been diligently working on the investigation. On September 9th members from White Butte Detachment formally charged, 23-year-old male, Rajwinder SINGH, residing in Regina in connection to this incident. SINGH was charged with two counts of uttering threats under Section 264.1 (1)(a) Criminal Code. File 2025-1044960 refers.

2 – On July 28th, White Butte Detachment received two complaints. One from the Town of White City of a fraud being committed against them. Secondly, the RM of Edenwold lodged a complaint of a fraud being committed against them. The two separate frauds are in excess of \$900,000.00. The Town of White City has been able to recover a portion of the funds that had been stolen. Members continue to investigate and are writing judicial authorizations in efforts to find out more information and any leads. File 2025-1086694 refers.

3 – On August 15th, White Butte members received a complaint from a business owner and resident in the detachment area that their ranch has been defrauded of nearly \$300,000.00 by someone known to their bookkeeper / accountant. Members have been investigating and are confident that a suspect has been identified and the incident will be resulting in the laying of charges in the near future. File 2025-1190698 refers.

4 – On August 28th, White Butte Detachment received a call from a manufacturing business in the Detachment's area that they had received an order for industrial equipment from customers they routinely conduct business with. The equipment was loaded and shipped, out of province, under fraudulent circumstances. Members are investigating further. File 2025-1267125 refers.

5 – On August 31st, Fire and RCMP responded to a house fire in the Town of Pilot Butte. The fire was happening on Aspen Crescent. The fire had spread and ended up damaging the two adjoining houses on either side of the property. Members contacted the Provincial Fire Scene examiners office to attend and determine the origin and cause of the fire. The file is still under investigation to determine if any criminality was involved. File 2025-1284220 refers.

6 – On August 31st, RCMP responded to the Town of Balgonie for a male in suspected medical distress. Members attended to the scene and found the male was in fact deceased. The family was present at the scene. Members began to investigate and have determined that there was no criminality involved in the death. File 2025-1285257 refers.

7 – On September 3rd, RCMP members were investigating a case of suspected possession of stolen property in the RM of Sherwood, just north of the City of Regina. The investigation ended up in an arrest and a search warrant was executed on the rural property. Many recovered stolen items were seized from the property during the search. A 32-year-old male from Regina will be charged with possession of stolen property under Section 354(1)(b) of the Criminal Code. File 2025-1302728 refers.

8 – On September 9th, White Butte received a complaint from B.I. that they have been having a theft problem for the last few, to as many as, five years. They believe they are now aware of the identity of the person involved. They are requesting a police investigation into the matter. Members started to investigate the file determine that roughly \$30,000.00 worth of cleaning products and hand tools had been stolen. A 45-year-old male, Tagumpay TORRES, of Regina has been charged with Section 334(b) theft under \$5,000.00 X 3, 354(1)(a) possession of property obtained by crime under \$5,000.00 and 348(1)(a) break and enter with intent X 3. File 2025-1336542 refers.

#4. RPCC Investigations: 2 assaults, 1 possession for the purpose of trafficking a scheduled substance, 2 possession of a scheduled substance and 16 assistance files. Total for the reporting period is 21.
