# **#1. White Butte Detachment Staffing Update:**


- S/Sgt. Detachment Commander position is filled currently.

#### #3. Calls of Interest:

1 – On June 27<sup>th</sup>, White Butte members were called to Number 1 Highway at the bypass near the Town of Balgonie. The caller explained that a vehicle had went into the ditch after taking the west bound access onramp by the Flying J truck stop. The driver was suspected to be suffering from some type of a medical episode, such as cardiac arrest. Members and EMS attempted life saving measures with no signs of life present. The driver was pronounced deceased on scene by EMS. There were no other vehicles or persons involved with this incident. File 2025-907434 refers.

- 2 On June 28<sup>th</sup>, White Butte Detachment was called to a youth care facility near Pilot Butte where a 14-year-old was trying to assault staff with a metal hot dog cooker stick. The youth also had a lighter and was going to attempt to start a fire with a propane tank as the fuel. The youth was arrested and charged with Section 266 assault, Section 267(a) assault with weapon and Section 264.1(1)(a) uttering threats. File 2025-913527 refers.
- 3 On June 30<sup>th</sup>, White Butte members responded to a rollover vehicle collision involving a pickup and a semi unit hauling hay. The collision happened on Highway 10 between Balgonie and Fort Qu' Appelle near the Edgeley turnoff. The pickup was driving north bound. The semi was driving south bound. The driver of the pickup truck was pronounced as deceased on scene. The semi driver was unharmed. File 2025-926401 refers.
- 4 On July 2<sup>nd</sup>, White Butte Butte RCMP was called for service in the RM of Sherwood to the Southwest from the City of Regina. The call was due to a possible suicidal male that was last seen in the area by a friend. Members attended to the scene, found the male, and began to investigate a sudden death. The coroner's office was called, and they attended the scene as well. Investigation suggests that it was an apparent suicide. File 2025-937755 refers.
- 5 \*\*\*Original\*\*\*On September 26<sup>th</sup>, 2023 White Butte Detachment opened an investigation due to information received that there were drugs being trafficked in/at the Regina Provincial Correctional Centre. The investigation is open and active. So far there may be up to 16 inmates involved with the file as well as a Correctional Centre Guard that may or may not be involved in the trafficking. It is suspected that this will be an overly complex and involved file due to the number of people involved and the culture surrounding these types of offences. \*\*\*Update\*\*\* 2025-07-04 The investigation has now concluded with many judicial authorizations being sought and many days and weeks pouring over all the results of those judicial authorizations. Members have arrested and charged 44-year-old, Justin Amyotte, from Regina, a former correctional officer with Section 465(1)(c) conspire to commit indictable offence, Section 122 breach of trust by a public officer and Section 354(1)(a) possession of property obtained by crime over \$5000.00. File 2023-1434211 refers.
- 6 On July 18<sup>th</sup>, Regina Police Service sent the White Butte a historical sexual assault file which took place in the 2000's. The victim was being taken to a residence for daycare when they were very young. This happened in the Town of Kronau. The victim was five years old at the time. This investigation is extremely sensitive and will take some time to complete. File 2025-1028250 refers.
- 7 On July 21<sup>st</sup>, White Butte Detachment received a complaint from a victim couple advising they have received threats against their business and their family. Multiple threats have been coming to them through various social media platforms and appears to have ties to organized crime groups that operate overseas. Similar circumstances / complaints have been observed in other parts of Canada and are believed to be credible and quite concerning. RCMP have been working hard to identify persons of interest / suspects and have interviewed and understand

that there are currently now two persons of interest attached to the file. Members have been writing search warrants and production orders in efforts to bring the file to charge stage. Security measures have been established as well as safety planning with the couple. White Butte has additionally been working with task forces in British Columbia and Ontario as partners in this very large-scale investigation. Files 2025-1044960 and 2025-1123983 refer.

8 – On August 13<sup>th</sup>, White Butte Detachment received a complaint at the detachment from a spouse concerned that her husband was going to hurt himself. Safety planning was conducted and put into place with the spouse and the soc father. Members continued to investigate and took statements from all parties involved. During the investigation members learned that there were allegations being made of an assault that happened earlier in the springtime. 36-year-old, Michael Zapototsky from White City was charged with Section 276(a) assault with a weapon and Section 266 assault. File 2025-1182375 refers.

**#4. RPCC Investigations:** 8 assaults, 1 possession of weapon for a dangerous purpose, 1 CDSA, 1 mischief, 1 suspicious person, 1 breach of trust and 3 assistance files. Total for the reporting period is 16.
