#### **#1. White Butte Detachment Staffing Update:**


- S/Sgt. Detachment Commander position is filled at this time.
- Sgt. OPS NCO position is currently vacant. Sgt. Steven Ross has been transferred and should be here the week of June 2<sup>nd</sup>, 2025.
- Both Corporal positions are filled at this time.
- White Butte has two Constable vacancies.
- One Cst. has been transferred, sold his house and is due to be here in mid July.
- One Cst. will be receiving a transfer notice around July 1<sup>st</sup>. They will be here in August sometime should all things work out.

#### **#2. Calls for Service: Analysis last 28 days (April 17, 2025 to May 15, 2025)**

### **#3. Calls of Interest:**

1 – On October 24<sup>th</sup>, White Butte members responded at a call in the RM of Sherwood about a suspicious trailer. The trailer was sitting behind a building and it appeared that the lock was cut off the door. The trailer turned out to be stolen. The members attended to the scene and started to investigate. During the investigation the member seized some evidence at the scene which was sent off to the crime lab for analysis. The lab conducted their examination, and it was found that the evidence seized came back to a known offender that was already in the database. Charges are pending and will be laid in relation to the case. File 2024-1574050 refers.

2 – On April 4<sup>th</sup>, White Butte members were called by B.I. to report a fraud. Members have begun a full-scale investigation into a workplace attendance fraud via time sheets. The investigation is progressing and all signs are pointing to criminal charges. The file will be a very large-scale fraud. File 2025-438989 refers.

3 - On April 17<sup>th</sup>, White Butte members were dispatched to a single vehicle rollover on the Bypass NW of the City of Regina on the ramp to Highway # 11. Members arrived on scene and started to investigate. There was one occupant of the vehicle that was deceased. The other/s involved were taken to the hospital for treatment. The coroner attended the scene as well as the RCMP traffic analyst. Members have been working hard for the deceased's family. Members have been working diligently on the investigation as well as writing two different search warrants. Criminal charges pending. File 2025-502906 refers.

4 – On April 25<sup>th</sup>, White Butte members were called to D. I. to a report of a male in cardiac arrest by Regina EMS. Members attended to the scene to investigate and found a male was deceased. The scene was not indicative of a workplace injury death. No signs of any foul play were located at the scene or on the body. Coroner was contacted during the investigation. File 2025-543911 refers.

5 – On April 25<sup>th</sup>, White Butte members received a call to Highway #48 near the town of Davin. The complainant reported that his dog was hit while it was running across the highway and the driver of the offending vehicle did not stop after the collision. The complainant tried to flag down the driver to no avail. Members continued with the investigation to identify the driver responsible for leaving the scene of an accident. The driver was charged with Section 253(2)(a) TSA. For failing to notify an owner of property damage. File 2025-546899 refers.

6 – On May 3<sup>rd</sup>, White Butte members received a complaint of a car that was swerving all over the Highway # 1 and speeding. Multiple complaints were received about the poor driving. The complainant guided members to the vehicle and a roadside stop was completed on the driver. The driver was arrested and brought back to the detachment for breath samples. 23-year-old Peyton Keshane from Yorkton was charged with Section 320.13(1) dangerous operation of a motor vehicle, Section 320.14(1)(b) operation over 80 mg% of a motor vehicle and Section 320.14(1)(a) operation while impaired of a motor vehicle under the criminal code. File 2025-591709 refers.

7 - On May 10<sup>th</sup>, White Butte Detachment received a call about an impaired driver near White City / Emerald Park between Highway #1 and Highway #33 on the 624. Members made patrols for the vehicle and ended up finding it and pulled it over. The driver admitted having drank some alcohol and subsequently provided a sample on the approved screening device. Members continued to investigate and ultimately ended up arresting and charging 26-year-old Reece Dayson from Cupar with Section 320.14(1)(a) adult operation while impaired and Section 320.14(1)(b) adult operation while over 80 mg% Criminal Code. File 2025-633345 refers.

**#4. RPCC Investigations:** 3 assaults, 2 possession of weapon, 1 aggravated assault, 1 assault with a weapon, 3 sexual assaults and 10 assistance files. Total for the reporting period is 20.
