#1. White Butte Detachment Staffing Update:

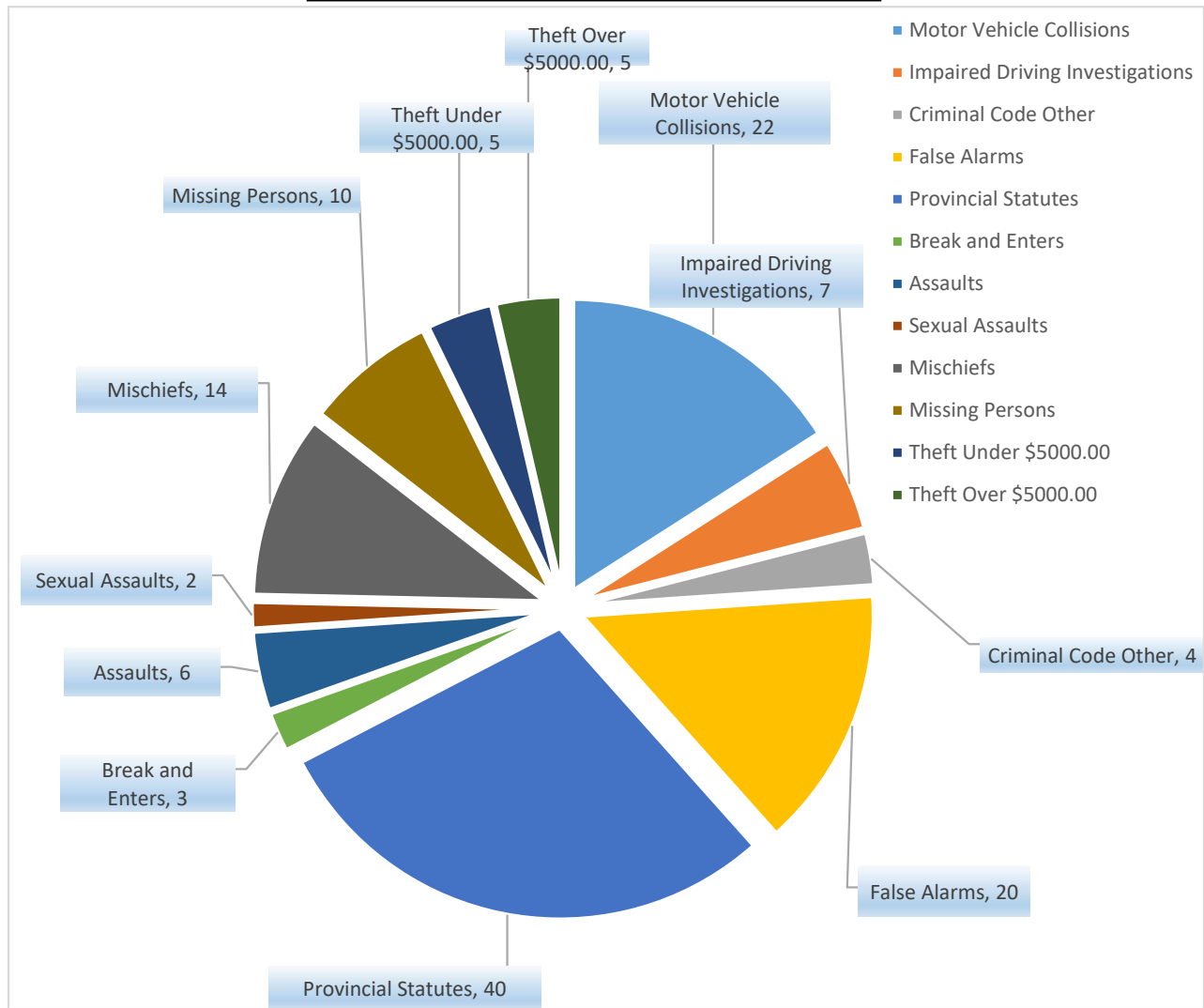
- S/Sgt. Detachment Commander position is filled currently.
- Sgt. OPS NCO position is filled currently.
- Both Corporal positions are filled currently.
- White Butte has one Constable vacancy. The member is Cst. Lisa Sask coming to us from La Ronge. We are making plans right now to have her start in December. Very excited to have her join the White Butte Team.

#2. Calls for Service: Analysis last 35 days (October 16, 2025 to November 20, 2025)

#3. Calls of Interest:

1 – On October 28th, White Butte members received a call from Regina EMS advising that there was a sudden death in the Town of Balgonie. RCMP members attended the residence and met with the neighbour who had been asked to check on the occupant on behalf of their family. Members investigated and learned that the occupant was last seen a few days ago. Members confirmed that the occupant was deceased and there was nothing criminal or suspicious in nature after completing the investigation. The coroner did not have any concerns or suspicions about the death. File 2025-1602507 refers.

2 – On October 28th, White Butte Detachment received a call from Prince Alber 911 dispatch centre. They advised that a call had been placed from the Regina Provincial Correctional Center of a male caller that said all prisoners are being held captive at RPCC. Members from the detachment called RPCC to see what the matter was. Further investigation turned up negative and everything was, as it should be at the correctional facility. File 2025-1602851 refers.

3 – On November 2nd, White Butte members on duty were called by Regina Police Service who advised they were investigating some stolen property and were conducting surveillance in RCMP jurisdiction. The suspect vehicle under surveillance made a meet with an unknown vehicle. During the meeting shots were fired between the two vehicle's occupants. Both vehicles then headed back into the City of Regina where a high-risk takedown was initiated and completed. Five persons were arrested. There were no injuries reported and no police officers were hurt. Regina Police Service has charged Jamie Desjarlais, Kevin Quewezance and Mikayla Minaker with multiple criminal code firearms offences. File 2025-1632206 refers. File RA25068957 refers.

4 – On November 13th, White Butte was called to the Regina Provincial Correctional Centre for a sudden death of an inmate by EMS around 11:30 am. White Butte members attended the scene and started to investigate. The deceased male was last observed at breakfast time. Statements were taken from witness staff and inmates. No foul play was observed or collected by members. Major crimes unit was consulted with. Autopsy was completed on November 14th. No charges will be stemming from this investigation. File 2025-1682908 refers.

5 – On November 13th, White Butte members received a call to the rural area outside of Grand Coulee. The caller was advising that someone was stealing his black 2019 Chevrolet 3500 dually. The truck was being taken from his field. Members headed to the scene. The male advised that hooked up to the truck, was a flatbed trailer and a skid steer. Members continued to investigate and with assistance from Lumsden Detachment and Regina Police Service Air Unit who located and attempted a stop on the stolen truck. The stops were unsuccessful and TDD was utilized. The vehicle ended up in the town of Lumsden and the male fled and shortly after was arrested. 47-year-old Randy Heilman from the RM of Lumsden has been charged with possession of property obtained by crime over \$5000.00 Section 354(1)(a) Criminal Code, operation while prohibited Section 320.18(1)(b) Criminal Code, dangerous operation of a motor vehicle Section 320.13(1)(b) Criminal Code, resist/obstruct peace officer Section 129(a) Criminal Code, flight from police officer Section 320.17 Criminal Code. File 2025-1684306 and 2025-1684709 refers.

6 – On November 17th, White Butte detachment received a call of a break and enter, to a residence, in the Town of Pilot Butte. The complainant advised that a known person, hired by the complainant, was responsible for the break and enter and the theft. Members began to investigate the matter to determine that around 14,000.00 of tools and material was missing. Further investigation revealed that the matter was more civil in nature, than it was criminal. Civil court was suggested to both parties. File 2025-1702170 refers.

7 - On July 28th, White Butte Detachment received two complaints. One from the Town of White City of a fraud being committed against them. Secondly, the RM of Edenwold lodged a complaint of a fraud being committed against them. The two separate frauds are in excess of \$900,000.00. The Town of White City has been able to recover a portion of the funds that had been stolen. Members continue to investigate and are writing judicial authorizations in efforts to find out more information and any leads. *****UPDATE***** New banking information has been provided through the Town of White City and their correspondence with their bank. Judicial authorizations are being written for multiple accounts tied to this crime. Police should know more in three plus weeks. File 2025-1086694 refers.
