### **#1. White Butte Detachment Staffing Update:**


- S/Sgt. Detachment Commander position is filled currently.

#### #3. Calls of Interest:

1 – On July 29<sup>th</sup>, White Butte Detachment received a complaint from B.I. of yet another serious fraud concerning their freight division. One of the managers is being investigated for awarding certain freight carriers of their choosing, contracts that are over the normal amounts. These overages are then suspected to be kept by the manager lining their pockets. Essentially being paid for awarding loads. Members have been investigating the file, and no charges have been laid as of yet. File 2025-1307380 refers.

- 2 On September 11<sup>th</sup>, White Butte members received a complaint at the front counter of the detachment. One of the owner's and the general manager from a local business in Emerald Park came to lodge a complaint of ongoing sexual assault concerns within the workplace. One of their employees have advised that a kitchen supervisor has been sexually assaulting employees for a while now. This prompted a large-scale investigation into the allegations being made from the employees. The RCMP has charged 25-year-old Nolan Smith from Regina with sexual assault, Section 271 and criminal harassment, Section 264 Criminal Code. File 2025-1349903 refers.
- 3 On October 2<sup>nd</sup>, White Butte members received a 911 call from a victim that said he was a hostage. The victim said he was being held against his will, in his vehicle, by the SOC. At the time of the call the victim was advising that the SOC was sitting in the vehicle with a weapon. The SOC wanted the victim to help him steal a vehicle from a local business. Members attended to the scene and began to investigate. The male SOC was arrested and the firearm that was used was seized. Members continued to investigate at the scene. Members transported the male back to the detachment for further questioning. White Butte ended up charging 35-year-old Gary RIDDELL of Regina with adult kidnapping Section 279(1.1)(a), adult extortion Section 346(1.1)(a), assault Section 266, unauthorized possession of a weapon Section 91(2), possession of a prohibited weapon Section 92(2), fail to comply with release order Section 145(5)(a) and possess break in instruments Section 351(1) of the Criminal Code. File 2025-1467052 refers.
- 4 On October 4<sup>th</sup>, White Butte members were dispatched to Highway # 1, east of White City, to where there was report of a black Dodge pickup truck that was parked suspiciously, and the driver appeared to be passed out behind the steering wheel. The vehicle was reported to be about 70 percent in the driving lane and 30 percent in the shoulder lane. The caller would wait on the scene for members to arrive with their hazard lights on. Members arrived on scene and began to investigate. 48-year-old Jessica Deiter from Peepeekisis First Nation was arrested and charged with impaired driving under Section 320.14(1)a) Criminal Code and operation while over 80 mg% under Section 320.14(1)(b) Criminal Code. File 2025-1476335 refers.
- 5 On October 4<sup>th</sup>, White Butte members responded to a call on the Pilot Butte access road between Highway # 1 and Pilot Butte. The complainant advised that there were calling to report a female walking down the highway in the dark with no clothes on. Members attended the scene and found a 32-year-old female from the City of Regina. Investigation revealed that she was from a group home in the city. She was picked up by an unknown male and driven out of the city to a field near where she was walking. She was taken to RGH and examined for any injuries. File 2025-1480798 refers.
- 6 On October 5<sup>th</sup>, White Butte members were called to an area near the Town of Balgonie. The Balgonie Fire Department advised that there has been a dirt bike collision with injuries. Members attended the scene to investigate. Two friends were out dirt biking together but at the time of the collision they were not in close proximity to each other. One male hit a dirt mound at and went up in the air. Injuries occurred upon impact. Protective equipment was

being worn. The male youth has suffered life changing spinal paralysis. File 2025-1482945 refers.
